ORGANISATION AIMS AND OBJECTIVES:

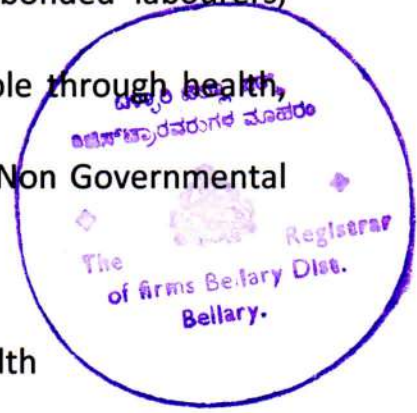
- a. To Conduct rural education both formal and non formal and vocational training along with animation, motivation and organization of poor, landless agriculture labors and literates

RULES AND REGULATIONS OF WEDS SOCIETY

1. Interpretation:

- a. The rules and regulations of WEDS are to achieve the objectives set forth in the memorandum of association
- b. The official year of the society shall be from the 1st April to 31st March every year
- c. The annual day of the society shall be 1st Jan. every year
- d. Jurisdiction shall extend to the areas of all over India

2. Membership:

The Members of society will consists of the following

- a. Every person who being eligible for membership pays Rs.51.00 as membership fee within a period of 20 days from the date of his selection as member of the society and pays annually the membership fee. As such person as may be invited by the society in accordance with these rules and regulations
- b. The membership of the society shall be more than 7 including the members of the governing body.

3. Cessation of Membership:

Membership of the society shall case;

- a. One is removed from the society by the society by the Governing body by a majority of regulation of the society

7.Meeting and Quorum of the Governing Body :

- a. The chairman shall convey all such meetings of the Governing body at such place and time as he may deem fit. Notice of the Governing body meetings specifying date, hour, place, etc. together with the agenda shall be sent to the members at least 15 days before the date fixed.
- b. In the absence of the chairman the Governing body members or the members of the general body as the case may be present at the meeting may elect any other member of the governing body as the chairperson of the meeting. unless the chairman in writing has specified assignee for the purpose
- c. The quorum for the meeting of the governing body shall be more than 75% of the total number of the governing body. if a meeting is adjourned for want of necessary quorum. no quorum is necessary for the adjourn meeting.

8.POWERS OF THE GOVERNING BODY

- a. The governing body shall have the control of and management of the affairs, services and administration M of the society and shall have such powers of the society enabling them generally to carry out the objectives of the society are required by the act. to be exercised by the society. the governing body shall have also the powers from time to time may very repeal rules and regulation of the society. And regulations of the affairs of bother itself and the society but no rules and regulations shall be made varies replaced by the vote power of the chairman or any of the existing objects of the society.
- b. To acquire immovable property of any tenure mainly in the state of Karnataka and also in any other part of the India, according to the needs of the society.

- b. If one deliberately commits and serious breach of the rules and regulation of the society.
- c. If one member becomes defaulter by not attending three consecutive meetings expect for reasonable cause and information in advance.
- d. If one willfully deceive the society by False statements, fictitious, documents and endeavor in any way defraud the society or acts against its interest.
- e. If one submit once resignation in writing and it is accepted by the Chairmen
- f. If the Society is dissolved or wind up

4. General Body:

- a. General Body consists of the Governing body other 2 members of the Society
- b. The quorum for General Body meeting shall be 50% of the membership or the Minimum 7 members with the right to vote which ever less. All matters Brought before the general Body shall be decided by a simple majority vote. the Chairman are the chair person of the meeting shall have a second vote in case of tie, voting by proxy shall not be allowed expect for the chairman
- c. Notice of the General body meeting of governing body or any other committee may be given to members, thereof respectively in such a manner as may be decided to time to time by the governing Body.
- d. The annual general body meeting shall be held before the end of December every year or as near thereof as possible each year at such time and places as the chairman may determine.

5. Powers of the general Body:

- a. Final authority in all matters concurring the society shall be vested with the general Body of the members, providing nothing shall effect adversely any powers conferred by these rules and regulations on the chairman governing Body or any employee of the society
- b. To receive the report of the governing Body, the accounts of the Society and its auditor's financial year ending 31st March within 14 days of the receipt of the report to be submitted to the register
- c. To approved of the budget expenditure for the ensuring year
- d. To tanant any other business which may be brought forward by any member of the governing body with the previous permission of the chairman or Chairperson
- e. To rectify any auction or vote of the governing body when called for.

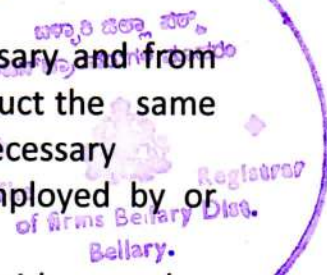

To use all income from the property movable and immovable or from workers of the society as such whenever derived. for the objects of the society as setforth in the memorandum of Association provided that no porting therefore distributed among its members by way of profits dividends or bonus



9. Chairman:

- a. The chairman shall preside over all meetings of the general body or the governing body
- b. He shall supervise the affairs, services of the society
- c. The chairman shall be chief Executive of the society, Empowered to transact all business of the society as decided From time to time by the governing body or general body.
- d. All correspondence and financial statements and returns and return to be prepared and audits and these are to be submitted to the registrar within 15 days of audit.
- e. The chairman shall be responsible for all the projects and programs of the society to be implemented effectively and truthfully .
- f. He may disburse salaries, sanction leave, appoint, substute to employees of the society.
- g. generally to do all such other things as may be deemed by the governing body to incidental or condensive to the attainment of any or some of all the objects of the society. But totally accountably to the Governing body

10.TREASURER:

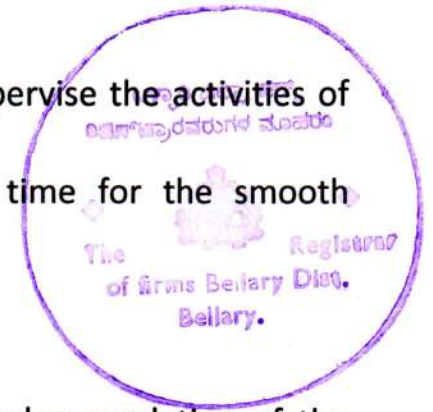
- a. in the absence of chairman, the treasurer will preside over the general body meeting

13. AMMENDMENT CLUASE:

- a. For amendments of memorandum of association and rules and regulation, the Karnataka society Regulation Act. 1960 section 9 and 10 are to be followed these amendments come to effect only when the approval of registrar is obtained.
- b. No amendments to the memorandum of association and rules and regulation shall be made which may prove to the repugnant to the provisions of the sections 2(15), 11, 1.13 and 80g the I.T. Act 1961 as amendments shall be carried out without the prior approval of the registrar
- c. If any matter not included in the rules and regulations and is left out they shall be followed according to the rules and regulations of the Karnataka Society's Act. 1960

14. ACCOUNTS CLAUSE:

- a. There shall be maintained all accounts of the society regularly. The accounts shall be audited by the chartered Accountant every year and accounts shall be closed by 31st March.
- b. At the end of financial year the accounts shall be prepared by the secretary according to companies Act 1956 rule 96 and be audited and then presented to the general body meeting for approval
- c. After the approval of the governing body, general body these accounts are to be submitted to the registrar within 14 days by the Chairman (sec.13 of the KSR Act 1950)
- d. The Bank account will be operated in the name of the society in any nationalized bank or any other Bank and will be jointly operated by the Chairman and Secretary. The will do all the transactions from time as per the needs of the society

15. ARBITRATION:

In the event of any different of opinion among the members of the governing body on any matter shall be referred for the decision of the chairman who may consult expert or legal advisor or others and his decision shall be accepted by the governing body and general body

16. DESOLUTION OF THE SOCIETY:

WEDS Society can be dissolved according to the Karnataka society registration act 1960 rule 22 and 23 in the event of dissolution of windings up of the society. The assets remaining as on the date of dissolution under no circumstances be distributed among the members of the managing committee or the governing body but same shall be transferred to charitable trust or society whose objects are similar to those of this society and which enjoys recognition U/S. of the I.T. Act 1961 as amended from time to time.
